# 2 Product description

The Starter Set A is designed for the manual use of the NucleoSpin<sup>®</sup> 8-well strips on the NucleoVac 96 (REF 740681), the Qiagen QiaVac 96, or for automation of the strips on common liquid handling instruments equipped with a standard 96-well plate vacuum chamber.

The set contains two Column Holders A to hold the NucleoSpin<sup>®</sup> 8-well strips and NucleoSpin<sup>®</sup> Dummy Strips to close the unused rows of the Column Holder A.

It allows flexible processing of the NucleoSpin® 8 kits by using one to six strips per run.

## 3 Handling

The desired number of 8-well strips is placed in the Column Holder A. Make sure that the 8-well strips are in the right orientation and attach to the Column Holder with a click. Unused rows of the Column Holder are closed with NucleoSpin<sup>®</sup> Dummy Strips. The Column Holder is then inserted into the lid of the NucleoVac 96 (see setup with NucleoSpin<sup>®</sup> Binding Strips, see page 5).

If using a kit with filter and binding strips (e.g., at the filtration step using the NucleoSpin<sup>®</sup> 8 Plasmid kit), the binding strips are inserted in one of the Column Holders. Empty rows are filled with NucleoSpin<sup>®</sup> Dummy Strips. The Column Holder is then placed onto the spacers 'MTP/MULTI-96 PLATE' inserted into the manifold base. The second Column Holder is loaded with the filter strips and inserted into the manifold lid. The manifold is then assembled (see setup with NucleoSpin<sup>®</sup> Filter Strips and NucleoSpin<sup>®</sup> Binding Strips, see page 6). After filtration, the lower column holder is transferred to the manifold lid for binding.

Elution is performed into a Rack of Tube Strips or an Elution Plate. Using the Elution Plate, spacers 'MTP/MULTI-96 PLATE' are needed. Please see the relating kit's user manual for more information regarding specific requirements.

### Setup with NucleoSpin® Binding Strips

#### Binding / Washing / Elution in MTP



#### Step 4:

Place the NucleoSpin® Binding Strips inserted the Column Holder A on top of the manifold lid. Unused rows have to be filled with NucleoSpin® Dummy Strips.

Step 3: Place the manifold lid on top of the manifold base.

Step 2: Place the MN Wash Plate in the manifold.

Step 1: Insert spacers 'MTP/MULTI-96 PLATE' in the manifold base.



#### Elution in Rack of Tube Strips

#### Step 4:

Place the NucleoSpin® Binding Strips inserted the Column Holder A on top of the manifold lid. Unused rows have to be filled with NucleoSpin® Dummy Strips.

#### Step 3:

Place the manifold lid on top of the manifold base.

Step 2: Place the Rack of Tube Strips in the manifold.

Step 1: Insert spacers 'MICROTUBE RACK' in the manifold base.

### Setup with NucleoSpin® Filter Strips and NucleoSpin® Binding Strips

#### Step 4:

Place the NucleoSpin® Filter Strips in the second Column Holder A and place it on top of the manifold lid. Unused rows have to be filled with NucleoSpin® Dummy Strips.

#### Step 3:

Place the manifold lid on top of the manifold base.

#### Step 2:

Put the NucleoSpin® Binding Strips in the first Column Holder A and place it in the manifold.

Step 1: Insert spacers 'MTP/MULTI-96 PLATE' in the manifold base.

### 4.1 Troubleshooting

Problem	Possible cause and suggestions
	Strips not inserted properly
Vacuum not sufficient	<ul> <li>Make sure that the strips are properly attached to the Column Holder and that the small gaskets sealing the strips are clean and intact.</li> </ul>
	Column Holder not inserted properly.
	Check gasket of the vacuum chamber and clean if necessary. Insert the Column Holder properly.
